THE JOSH HESS ERA KICKED OFF FOR PEARL RIVER Community College women's and men's soccer, as the Ohio native took over the reins of the two programs in 2007.

Hess, a native of Cincinnati, Ohio, served the 2006 season as assistant coach under three-year head coach Patrick Hayes who resigned the position to accept the head men's coaching position at Gulfport High School.

"We're excited about Josh being promoted to head coach," PRCC athletic director Richard Mathis said. "He did an excellent job for us last year and I'm confident he'll take up where we left off and keep our women's and men's programs as competitive as they always have been."

"The players like him and relate to him and, above all, he has an excellent background in soccer as a standout player and a coach."

Hess is a graduate of Hillsboro High School where he was a standout soccer player. He earned first-team All-League honors his junior and senior seasons.

From there, Hess earned a bachelor of science degree in sports medicine from Mt. Vernon Nazarene University and went on to earn a master of science degree in accounting from the University of Cincinnati.

Hess played collegiately at SUNY Fredonia in Fredonia, N.Y., and at Mt. Vernon Nazarene.

In the five years prior to his arrival at Pearl River, Hess coached club soccer with the Lakota and North Kentucky soccer clubs and also coached for both the Kentucky and Ohio South Olympic Development Programs.

In addition, Hess holds the National Youth License, the NSCAA Advanced National Diploma, and the USSF National "B" Coaching License.

Hess is married to the former Julie Hellings of Florence, Ky.
